Freedom of Information Act 2000

Thank you for your Freedom of Information request received 15th March 2022. Your request has been dealt with under the terms of the above legislation. You requested the following information:

In order to better understand the state of housing need in Belfast, we request

- 1. the most recent residual need figures broken down by HNA area (North, West, South/East Belfast). (If your mechanism for calculating residual need has changed at all since your FOI 21 104 to us dated 28 May 2021 please indicate this and provide an update on the methodology.)
- 2. the most up to date estimates available on the current total number of social housing units there are in use / fit for use (including Housing Executive and housing association social housing units), by HNA area.

Part two of your request was responded to by our Housing Services Division on 28th April 2022. You were advised at that time of receipt of your FOI that the information requested in part one would not be available until mid-May, as Housing Need Assessment is an annual exercise that is not completed until May. You agreed that you were content to wait for the information requested in part one to become available.

The table below provides the most recent residual need figures for Belfast broken down by HNA area. These figures are as at 31st March 2022.
